# ENTITLEMENT FOR SCHOOL YEAR (SY) 2019–20

- Entitlement Amount: \$194,059,741
  - Meal rate: \$0.3625
  - SUPER: \$85,358,450
- Department of Defense Fresh (DoD Fresh) Entitlement: \$26,507,500
  - SUPER: \$13,870,302
- Unprocessed Fruit and Vegetable Pilot Entitlement: \$3,268,750

<b>100237</b>	100236	Cherries, tart, unsweetened, frozen	Change in pack size from 40 lb pail to 12/2.5 lb packages
<b>110871</b>	111230	Mixed vegetables, no salt added, frozen	Change in pack size from 30 lb case to 6/5 lb packages

  - First orders due late March, 2020
